- (3) I agree that I will comply with the spirit and terms of the Club Permit Scheme as set out in the Road Safety (Vehicles) Amendment (Club Permit) Regulations 2010 and any consequential or supplementary requirements of VicRoads. I understand that failure to do so may result in suspension or cancellation of a Club Permit issued for the above vehicle.
- (4) I agree that in the event that I discover that the vehicle may not be safe for use on a highway I will advise the Club and take all necessary steps to rectify the problem within 14 days. In the event that the problem cannot be rectified within 14 days I will advise the Club of the reasons why the problem cannot be so rectified and the projected date of rectification.
- (5) I will notify the Club in writing within 14 days if I sell or otherwise dispose of the above vehicle. I further agree that if I sell or otherwise dispose of the vehicle I will destroy the Club Permit Logbook and the Club Permit as required by the Regulations and remove and return the Club Permit number plates to VicRoads.
